ORDER

(Denying ECF No. 1800 as Moot and Dismissing Certain Cases with Prejudice)

Pending in MDL 2187, 2:10-md-2187 [ECF No. 1800], is a Joint Motion to Dismiss Defendants With Prejudice filed by plaintiffs, identified on the attached Exhibit A, C. R. Bard, Inc., (“Bard”), and Sofradim Production SAS,¹ Tissue Science Laboratories Limited,² and Covidien LP³ (collectively the “Covidien entities”). Plaintiffs, on the attached Exhibit A, Bard, and the Covidien entities have now filed an Amended Joint Motion to Dismiss Defendants with Prejudice seeking dismissal of these actions with prejudice because all claims have been compromised and settled,

including all claims, counterclaims, cross-claims and third party claims [ECF No. 1884]. After careful consideration, it is **ORDERED** that the Joint Motion to Dismiss Defendants with Prejudice [ECF No. 1800] is **DENIED AS MOOT**. The Amended Joint Motion to Dismiss Defendants with Prejudice [ECF No. 1884] is **GRANTED**. It is further **ORDERED** that the actions listed on the attached Exhibit A are **DISMISSED WITH PREJUDICE** and **STRICKEN** from the docket and any motions pending in the individual cases at the time of this dismissal are **DENIED AS MOOT**.

The court **DIRECTS** the Clerk to file a copy of this order in 2:10-md-2187 and in the individual cases listed on the attached Exhibit A.
