ORDER


(Dismissing Defendant C. R. Bard, Inc. with Prejudice
and Transferring Cases to MDL 2326)

Pending in MDL 2187, 2:10-md-2187 [ECF No. 3848], is a Joint Motion to Dismiss Defendant C. R. Bard, Inc. with Prejudice filed by the plaintiffs, identified in Exhibits A-C, (attached hereto) and C. R. Bard, Inc. (“Bard”). The parties are seeking dismissal of Bard as a defendant in these actions with prejudice because all claims against Bard have been compromised and settled, including all claims, counterclaims, cross-claims and third party claims. Also pending is Plaintiffs’ Motion to Transfer MDLs for these cases [ECF No. 3848]. After careful consideration, it is **ORDERED** that the Joint Motion to Dismiss Bard with Prejudice is **GRANTED**. It is further **ORDERED** that the **MOTION TO TRANSFER MDLs** is **GRANTED**. To the extent Amended Short Form Complaints have not been filed, plaintiffs’ counsel are **DIRECTED** to file the appropriate Amended Short Form Complaints within the time frame outlined in their Motion. Defendant Bard is **DISMISSED WITH PREJUDICE** as a defendant in the actions listed in Exhibits A-C, these actions are

TRANSFERRED to MDL 2326, and the Clerk is directed to disassociate these civil actions as member cases in MDL 2187 and re-associate them with MDL 2326.

The court **DIRECTS** the Clerk to file a copy of this order in 2:10-md-2187 and in the individual cases listed in Exhibits A-C.
